Graduation Information

APPLICATION

A Graduation Application must be filed in the Admissions and Records Office by the deadline date as published in the current term's class schedule.

NOTIFICATION

An evaluation will be mailed to you approximately 12 weeks after the application deadline.

Eligibility for graduation is based upon all degree applicable coursework taken at Fullerton College and other regionally accredited colleges or universities.

Official transcripts from all other colleges or universities **must** be on file at Fullerton College by the application deadline.

DIPLOMA

Diplomas are mailed to the address indicated on the graduation application approximately 12 weeks after the end of the term. If you have a change of address after applying for graduation, you **must** notify the Evaluation Unit, in addition to the Admissions and Records Office.

HONORS

Students who graduate with a cumulative grade point average of 3.30 are automatically granted Honors. Those who have a cumulative grade point average of 3.75 are granted High Honors.

COMMENCEMENT

Commencement exercises are held once a year at the end of the Spring term. The previous Summer and Fall graduates, as well as the current Spring candidates for graduation, are automatically invited to participate. Details for participation will be mailed in early May.
